MEMBERSHIP POLICY and CODE OF CONDUCT
FAMILY YMCA OF EMPORIA-GREENSVILLE

SAFETY AND SECURITY

We value the security and safety of our members and staff and therefore enforce the following policies:

- 1. All members and guests are expected to act appropriately at all times when in our facilities, on our property, or participating in our programs and to adhere to the values of the YMCA - Caring, Honesty, Respect, Responsibility and Faith.
2. The YMCA conducts regular sex offender screenings on all members, participants, and guests. If a sex offender match occurs, the YMCA reserves the right to deny or cancel the membership, end program participation, and remove visitation access.
3. The following actions or behaviors WILL NOT be tolerated:
a. The use of language or actions that can hurt or frighten another person.
b. Physical contact with another person in an angry or threatening way.
c. Any demonstration of sexual activity or sexual contact with another person.
d. Harassment or intimidation by words, gestures, body language or any menacing behavior.
e. Theft or behavior that results in the destruction of property.
f. Carrying any weapons, devices or objects that may be used as weapons.
g. Possession or use of any illegal chemicals, narcotics or alcohol while on Y premises or involved in Y programs.
h. Refusal to verify identity when asked by YMCA staff.
i. Loitering on Y property.
j. Commission of misconduct in the opinion of YMCA administration.

NATIONWIDE MEMBERSHIP

Active full facility members may visit other YMCAs that participate in Nationwide Membership as long as they use their home YMCA 50% of the time. Registered sex offenders are not eligible to participate. When visiting another YMCA, members will be required to show a valid YMCA membership card and state issued photo ID as well as basic membership data such as name and email address. Members will need to sign a universal liability waiver and privacy policy upon entry. YMCAs that participate in Nationwide Membership typically offer full access and services. Nationwide members visiting other YMCAs for a period greater than 28 days must transfer membership affiliation for continued use. All YMCAs reserve the right to restrict or revoke these privileges. By participating in the YMCA Nationwide Membership program, I agree to release the National Council of Young Men's Christian Associations of the United States of America, and its independent and autonomous member associations in the United States and Puerto Rico, from claims of negligence for bodily injury or death in connection with the use of YMCA facilities, and from any liability for other claims, including loss of property, to the fullest extent of the law.

Silver Sneakers, Silver & Fit and Renew Active participants are not eligible for Nationwide Membership. Some Ys that honor these programs may allow you to confirm eligibility and enroll at their location to participate or may deny participation entirely.

PHOTOS/AUDIO VISUAL AND NARRATIVE RELEASE

To obtain a Y membership, all members are required to have their photo taken and stored within YMCA membership software. By signing below, I state that I am 18 years of age or older and, if not, my parent or legal guardian has also provided their consent by signing below. Consent & License: For my participation in activities to be conducted by the National Council of Young Men's Christian Associations of the United States of America ("YMCA of the USA") or any of its chartered member associations in the United States (collectively "the Y"), and collaborating third parties, I consent, now and for all time, to the making, reproduction, editing, broadcasting or rebroadcasting of: 1) video film or footage of me; 2) soundtrack recordings of me; 3) photo reproductions of me; 4) any narrative account of my experience. My consent includes a perpetual license to the Y and collaborating third-parties for the use of the above materials for publication, display, sale or exhibition in promotions, advertising, educational and commercial uses. Use includes reproductions in any form and media currently existing or later conceived, adaptation and/or revisions, through the world in perpetuity. I understand and agree there may be no additional compensation for this license, and I will not make any claim for payment of any kind from the Y or collaborating third-parties. I may, or may not be, identified in such licensed uses; however, my name will not be used to endorse any particular products or services. Ownership, Confidentiality, and Shared Use: With respect to any of the above uses, I further agree: 5) All works shall belong to the YMCA of the USA; 6) The Y has no duty of confidentiality regarding any licensed uses; 7) YMCA of the USA shall exclusively own all known or later existing rights to the uses throughout the world; 8) The Y and collaborating third-parties may use any video film, footage, sound track recordings and photo reproductions of me and/or my narrative account for any purpose without additional compensation to me. Release from Liability: I agree that my consent is irrevocable. I hereby release and discharge the Y and collaborating third-parties, from any and all claims, actions, lawsuits or demands of any kind arising out of my consent, license grants, uses, or the shared uses of any works or materials referenced herein.

MANDATORY RISK WAIVER

I understand that recreational activities have inherent risks which are beyond the control of the Y, their staff, volunteers and members. I understand that upon using the facility and services that I hereby assume all risks for the behavior, actions and safety of myself and any person included in my Y membership. I certify that neither I nor any person included in my membership have any physical condition that would prevent the safe engagement in an exercise program or Y activities, and that I have been advised to seek the advice of a physician before starting any exercise program or engaging in any physical activity. I further agree to hold harmless the Y for any theft, loss or damage of personal property while on Y property or participating in a Y event or program. I have read and understand these policies and release of liability, and do voluntarily sign in agreement and intent to abide by these standards.

YMCA MONTHLY MEMBERSHIP DRAFT AUTHORIZATION

Membership: YMCA memberships may be paid by a recurring monthly funds transfer/draft from your bank or financial institution or credit/debit card. Each payment renews your membership for another month beginning the first day and ending the last day and continues until you provide the Y with written intent to cancel or your membership is cancelled by Y administration due to an unpaid balance or a violation of the Code of Conduct or Membership Policy.

Joining Fee: A joining fee of \$35 - \$75 is a one-time fee as long as you remain an active member of the Y. If your membership is inactive for more than thirty (30) days, a joining fee will be charged when you reapply.

Due Date: All fees are due in full on the first (1st) day of each month; however, the Y offers members the option to defer their withdrawal date until the fifteenth (15th) if they choose.

Cancellation: Our Y requires no contract; therefore, you may cancel your membership at any time by providing written notification of your intent to the YMCA Membership Director. The day your intent is received, your Y account will be updated to end on the last day of that month. Because the due date for membership fees is the first (1st) day of each month, any payment deferred to the fifteenth (15th) of that month will be processed on the fifteenth (15th). Memberships may be cancelled by Y administration due to an unpaid balance at the end of the month or a violation in Code of Conduct or Membership Policy.

Refunds: Membership fees will not be refunded for non-usage.
